DECISIONS

The Süleyman Demirel University Education Program Evaluation Board (SDÜTF-EPDK) convened online on 2 March 2021 under the chairmanship of Prof. Dr. Alim Koşar. At the meeting:

1. It is appropriate for the course on the subject of "Health Law," proposed by Prof. Dr. Tekin Ahmet SEREL and discussed at the EPDK, to be offered as a Special Study Module (SSM) in Term 2 and Term 3.
2. It is appropriate for an integrated session (on subjects such as organ transplantation/donation, malpractice, etc.) to be planned in Term 3 together with the Department of Forensic Medicine, with the participation of Prof. Dr. Tekin Ahmet Serel.
3. It is appropriate for the 2-hour lecture on health law, taught within the Forensic Medicine clerkship in Term 5, to be given by Prof. Dr. Tekin Ahmet SEREL.
4. It is appropriate for 4 hours of seminars discussing health law topics to be placed within the Public Health internship program in Term 6.
5. It would thus be fitting for a health-law corridor, consistent with vertical integration, to be established across Terms 2, 3, 5, and 6; the decision reached to this effect, together with Items 1, 2, 3, and 4, is to be submitted to the MÖTEK.
6. The matter of opening a course on radiological instruments and equipment, proposed by the Department of Radiology — discussed at the Assessment and Evaluation Board (ÖDK) on 7 January 2021 and referred for evaluation at the EPDK — was discussed; it was decided that the course, in its proposed form, cannot be placed in the Faculty of Medicine's Education Program, that it does not comply with the National Core Education Program, and that the decision that the course could be given to students in the form of a "Special Study Module" is to be submitted to the MÖTEK.
7. The matter of creating an alternative communication channel to replace the WhatsApp group used for EPDK communications was discussed. It was decided that the Dean's Office would decide, by the next meeting, on which platform and how the meetings would be held, and that this decision would be awaited to be communicated officially.
8. It was decided that meeting announcements would be made by e-mail.
9. It was decided that the next meeting would be held at the same place on 6 April 2021 at 12:30.
