AGENDA ITEMS

1. Review of the matters to be carried out within the scope of the board's activities

DECISIONS

1. The March EPDK decisions were reviewed. It was reported by the Term 6 coordinator that requests have not yet been collected from the departments for the creation of 2 elective pools of 2 weeks each in Term 6, that the template for the clerkship guides has not yet been created, and that once it has been created, letters will be sent to the departments.
2. It was decided that a subcommittee be formed so that the Term 6 course schedule can be placed in the program and the clerkship rotations can be arranged.
3. The feedback received at the external-stakeholder meeting was shared. It was discussed that external stakeholders such as the Red Crescent (Kızılay), AFAD, and the Green Crescent (Yeşilay) stated that they are ready to have students carry out social-responsibility projects, that students could take part in social-responsibility activities by becoming members of these associations, and that this participation would provide students with positive gains in social-responsibility activities.
4. The topic headings that external stakeholders proposed be included in the education program were shared. These topics were stated to be reproductive health, narcotics, etc. It was also stated that the need to provide students with opportunities to increase their physical activity had come as a proposal from the external stakeholders.
5. It was stated by the board members that the student-advising system is not functioning actively, and that difficulties are experienced in ensuring meetings with the advisor unless a request comes from the students themselves.
6. According to information obtained from student feedback, it was shared that, in order for Erasmus students' 2-month exchange visits to be arranged, there needs to be a 2-month gap between Term 4 and Term 5; it was decided that, if feasible, it would be appropriate for the program to be arranged in this manner.
7. It was decided, unanimously, that the next meeting would be held on Tuesday, 7 May 2024.
