DECISIONS

1. The decisions of the previous meeting were reviewed.
2. Information was given regarding the meetings with intern physicians.
3. The Faculty of Medicine Education and Instruction Chief Coordinator's Office and Term Coordinators Working Directive, the End-of-Course-Committee Examination Evaluation Algorithm, the Integrated Session Implementation Directive, the Social Responsibility Course Implementation Directive, the Special Study Module Course Implementation Directive, the Special Study Module Course Implementation Directive, and the Project Implementation Course Implementation Directive were discussed and the board's opinions were obtained. It was decided that sub-paragraph (c) of paragraph B of the Term Coordinators Working Directive would be amended to read "to report to the EPDK the changes and new arrangements they consider should be made in the education programs"; and that the information in Article 8 of the Project Implementation Course Implementation Directive concerning the 2023-2024 and 2024-2025 academic years would be amended so as to cover all years in general. The other directives were accepted as they stand.
4. It was decided that separate practice questions would be asked for the Public Health Practice Courses in the Term 3 Course Committee examination, and that these questions would not be included in the assessment for students who were absent from the practice sessions.
5. The disruptions experienced in the Examod program and proposed solutions were discussed.
6. It was shared as information that, with the arrangement made, students are able to see their advisor faculty members through SDÜNet.
7. It was shared as information that work is continuing on collecting feedback surveys through the "Learning Management System."
8. It was shared as information that, in Faculty of Medicine Phase 2 (Terms 4 and 5), efforts are being made to conduct examinations through the "Examination Accreditation Module," that for this purpose question-to-learning-objective matching needs to be carried out, that the Department of Cardiology is using the system, and that the Departments of Internal Medicine and Nuclear Medicine will also begin using it.
