AGENDA ITEMS

1. Review of matters to be carried out within the scope of board activities

DECISIONS

1. Regarding the addition of the course "Combating Addiction," which has been made mandatory by YÖK (the Council of Higher Education) and passed by the Senate:

a. That the course be added to the program as a standalone course (to be added to the Term 1 program, in the Spring term, as 2 hours per week and 2 ECTS);

b. That the course's examination be conducted as in the joint/common courses (midterm 40%, final 60%);

c. That suitable hours for the course be determined in the program (this could be Tuesday or Thursday afternoon at 16:00), and that the Term 1 Coordinators begin the work needed to make the necessary arrangements;

d. That a suitable coordinator be appointed for the course (that the opinion of the university's addiction coordinator, Prof. Dr. Mustafa Saygın, be sought);

e. That, it having been stated that YÖK has expressed a favorable opinion to the effect that the course's content and presentations are ready, and that the opening lecture and closing lecture together with the first 5 topics could be delivered by the university's addiction coordinator's office, the topics included in the course program be notified in writing to the relevant departments (Department of Chest Diseases, Department of Family Medicine, Department of Public Health, Department of Emergency Medicine, Department of Pharmacology, and Department of Psychiatry) so that the faculty members who will teach the remaining lectures can be assigned;

2. That the Health Law course proposed by the representative of the Isparta Bar Association during meetings held with the Faculty's external stakeholders could be added to the course program (to the Term 3 and Term 6 Public Health Course Committee/clerkship), that this could be delivered in the form of an integrated session, and that, in addition, a speaker from the Bar Association could also be invited to the Career Days held for Term 6;

3. That 2 weeks be set aside in the Term 3 program on the dates on which the Project Days are held;

4. The proposal raised by the Chair of the Department of Radiology at the Academic Board of the Department of Internal Medical Sciences — that the 1-week Radiology clerkship is not sufficient for delivering lectures and conducting practical training, and that clinic-specific radiological practical lectures could be added if suitable space is given in the course program of the clinical clerkships — was discussed. It was decided that this view would be quite beneficial in terms of horizontal integration, but that work would begin only if this proposal is first discussed at the Academic Board of the Department of Radiology and a favorable opinion is expressed, and that the pilot study could begin with the Department of Pediatrics, which has expressed a favorable opinion regarding this proposal.

The decision was made unanimously.
