1. Review of matters to be carried out within the scope of board activities

DECISIONS

1. Following the decision taken at the meeting held in February, the draft text prepared by the Department of Medical Education and Informatics, containing updates related to our Faculty and our education program, was discussed. It was decided that the draft text, in its current form, would be opened for stakeholder opinion.
2. The letter titled "National Employment Strategy" received from our University's "Education-Instruction Branch Directorate" unit, and the questions contained in its attachment, were reviewed. It was decided that most of the survey questions in question were not directly related to the Faculty of Medicine, and that some of them needed to be answered at the University level. It was decided that the only question that could be related to our Faculty was the question asking about courses related to artificial intelligence. Regarding this question, it was stated that the courses related to artificial intelligence included in our Faculty's course program could be given as an example.
3. It was decided that a physician from the pharmaceutical sector would be invited as a speaker within the scope of the Career Days event for our Faculty's final-year students, and that the event would be held on 9 April 2026.
4. It was decided that certain course titles related to the hematopoietic system, included in our Faculty's Term 2 Course Committee 2 program, would be transferred to Course Committee 1.
5. It was decided that, for the 4th weekly period arising from our Faculty's Term 6 course program's conversion from the monthly system to the weekly system, a new clerkship titled "Competency Development Clerkship," carrying 5 ECTS, would be added; and that, in line with this, the ECTS credits belonging to the Internal Medicine, Emergency Medicine, and Child Health and Diseases clerkships would be reviewed, and stakeholder opinions would be obtained for opening the new course and for the ECTS change.
