1. Evaluation of the decisions taken at the previous meeting.

DECISIONS

1. The written and justified explanations of the resident physicians who did not attend the orientation training held on Wednesday, 20 November 2024, were examined. Upon evaluation of the explanations, the opinion was formed that the justifications were largely insufficient and that the resident physicians' non-attendance at the training had caused disruptions in postgraduate medical education. In this context, it was decided that a proposal would be made to the Dean's Office Administration for written warnings and feedback to be given specific to the relevant departments.
2. The written and justified explanations of the resident physicians who did not attend the "blue code/life support training" held by the Chairmanship of the Department of Anesthesiology and Reanimation were examined. Upon evaluation of the explanations, the opinion was formed that the justifications were largely insufficient and that the resident physicians' non-attendance at the training had caused disruptions in postgraduate medical education and continuous professional development. In this context, it was decided that a proposal would be made to the Dean's Office Administration for written warnings and feedback to be given specific to the relevant departments.
3. It was decided that the orientation training to be organized for residents placed at our Faculty according to the 2024 Term 2 TUS results would be held on 18 February 2025, and that the discussed orientation training topics were appropriate.
4. It was unanimously decided that the next meeting would be held in March 2025, with the follow-up of decisions as the agenda.
