4. It was decided that a letter be written to the Department Chairs to ensure that the scientific publication number standards specified in the current educational curricula accepted by the Medical Specialty Training Board be met.
5. It was decided that the new proposals made by MESTEK be added to the text "Procedures and Principles Regarding the Assignment of External Instructors at Süleyman Demirel University Faculty of Medicine" proposed by MÖTEK, and that it be submitted to the Faculty Board.
6. It was decided that the next meeting be held in November 2025 to follow up on the agenda items.
