DECISIONS

The Postgraduate Medical Education Board convened on 15 January 2026 at 11:30 in Hall B of the Dean's Office Building. It was unanimously decided:

1. That the orientation training of Research Assistant physicians who have begun medical specialty training at our Faculty be held face-to-face in February 2026.
2. That, at the end of the said orientation training, it is appropriate to have the physicians participating in the training sign a "Declaration of Responsibility Form" stating that they have been informed about their professional, ethical, and institutional responsibilities and that they accept these responsibilities.
3. That, as a result of the analysis of the results of the feedback survey administered to medical specialty trainees, it is appropriate to organize a "Specialty Training Interim Assessment and Orientation Program" for Research Assistant physicians who have completed approximately one and a half to two years of training.
4. That, in order to determine the needs and expectations for the planning of the said "Specialty Training Interim Assessment and Orientation Program," requests be collected from Research Assistant physicians by the Assistant Representative Dr. Özgür ÖZAY; and that the content and planning of the "Specialty Training Interim Assessment and Orientation Program" be carried out in line with the requests to be collected.
5. That, in line with the requests received from faculty members, a request be made to the Education Skills Board regarding the planning of a training on the subject of "Mobbing" for faculty members.
6. That the next meeting be held in March 2026 with the agenda of following up on the decisions.
