DECISIONS

1. Following feedback received from graduates and a request for the Family Medicine clerkship to be 4 weeks, the Term VI course program was reviewed. It was discussed that the Psychiatry clerkship, which is a mandatory clerkship in the Term VI program, could become an elective clerkship if the Term V curriculum meets the UÇEP-2020 requirements, and that, if it does not become an elective clerkship, the program would continue in its current form.
2. It was decided to begin work on determining the 2024-2025 Academic Calendar, and to convene at 12:30 on 29.04.2024 to determine the final form of the calendar.
3. It was stated that the necessary discussions would be held to determine the graduation date.
4. The Term VI representative conveyed the interns' request to be granted leave for the entire graduation day.
5. It was discussed that the social responsibility course to be added to the Term I program be scheduled for Friday afternoons in the course program. It was stated that, in terms of elective courses, the university-wide common elective courses held on Friday afternoons across the entire university could not be selected by our Faculty's students, as this would create an ECTS excess.
6. Due to students' requests to benefit from Erasmus placements during the summer period, it was stated that, when preparing the 2024-2025 course program, it needs to be evaluated whether the gap between Term 4 and Term 5 can be extended to 2 (two) months.
7. It was decided that the opinion of the Rectorate would also be obtained in determining the non-governmental organizations with which a protocol would be made for the social responsibility course.
