DECISIONS

1. It was stated that, when determining the academic calendar, the maximum interval that could be left — to the extent permitted by the intensity of the program — has been allowed for Term 4 and 5 students who wish to go abroad during the summer period.
2. As stated in the EPDK decision dated 07.05.2024, it was decided that it is appropriate for the Term VI Emergency Medicine clerkship to be organized as 6 weeks at the Emergency Department of the Faculty of Medicine Research and Practice Hospital and 2 weeks at the Emergency Department of Isparta City Hospital.
3. It was decided to request the 2024-2025 course programs from the term coordinators' offices.
4. It was found appropriate to request the Term VI course programs and clerkship guides.
5. It was decided that the elective course "Entrepreneurship - Technology and Innovation in Health," conducted under the supervision of Assoc. Prof. Dr. Giray Kolcu and included among the elective courses, would continue in the program, but that the student quota for this year would be set at zero.
6. It was decided that it is appropriate to add an OSAS (Obstructive Sleep Apnea Syndrome) integrated session to Term 3 Course Committee 3, the Respiratory-Circulatory System Committee, and to place it in the course program; to add an integrated session on "Basic and Clinical Approach to Pharmacogenetics" to Term 3 Course Committee 6 and to place it in the course program; to add the topic "Urogenital System Pathophysiology" to the existing STD (Sexually Transmitted Diseases) Integrated Session in the current program; and to add the topic "Pathophysiology of Addiction" to the existing "Drug and Substance Addiction" Integrated Session in Term 3 Course Committee 1.
7. The 2024-2025 course plans submitted by the coordinators were discussed and found appropriate.
