1. Review of the activities to be carried out within the scope of the Board's activities.

DECISIONS

1. It was reported that the Examod examination system could begin to be used for the Term IV and Term V written examinations.
2. It was stated that the intern guide contains suggestions on how term grades will be determined in Term VI. It was stated that oral or written examinations may be given in Term VI, but that these examination results should not be used alone as the clerkship grade, nor should clerkship grades be generated solely from these results; rather, the examination results could be used as a tool for forming a grade (such as for forming an overall impression).
3. It was decided that the Term 1, 2, and 3 Coordinators would carry out a study so that theoretical and practical examination grades could be viewed separately in the Examod and Proliz systems, and that a meeting on this matter would be held on Thursday, 2 May 2024, at 13:00.
4. It was decided that an informational guide would be created so that faculty members could enter questions using the Examod system.
5. It was decided that the social responsibility course to be added to the Term I course program would be implemented as a pilot in the 2024-2025 academic year. For this purpose, it was decided that a 6 (six)-hour social responsibility course worth [illegible] ECTS would be added, in which a different civil society organization would be featured in each course committee within the Term I course program.
