DECISIONS

1. The petitions of Term 1 students and the Term 1 Coordinator's Office regarding the method of evaluating cancelled questions were discussed. It was stated that, in accordance with the current examination directive, in the event of question cancellation the exam evaluation must be carried out on the basis of the remaining number of questions, and that this practice preserves the content validity of the exam. However, it was decided that the practices of other faculties in the event of question cancellation would also be examined.
2. Problems experienced with the new exam system were raised. It was stated that, in the event a wrong option is marked as the answer while preparing a question, no correction can be made by the faculty member who prepared the question. It was noted that difficulty is experienced in question entry because all steps related to question preparation are on the same tab, and a proposal was made that these stages could proceed tab by tab and that a revision tab could be added.
3. It was stated that, by also assigning authorization to assistant coordinators in the Examod exam system, the workload of the coordinators could be reduced.
4. It was requested that a tab be opened in the EBYS (Electronic Document Management System) so that coordinators can send correspondence to assistant coordinators.
5. It was stated that, in order to create a question pool in the Examod exam system, questions could be requested from faculty members collectively at the beginning of the education term.
6. It was decided that the Coordinators would inform the Dean's Office regarding faculty members whose questions are repeatedly cancelled in exams.
