DECISIONS

1. The minutes describing the situation verbally reported by the Term 3 Coordinator's Office at the March MÖTEK meeting, and the situation thereafter, were discussed. It was seen that the minutes mentioned an exam-reading error caused by the Examod system in the 4th end-of-course-committee theoretical examination held in Term 3, how this problem was resolved, and the delay in announcing the exam results caused by this problem. In the discussion held with the software company following the MÖTEK meeting, it was stated that this malfunction was not caused by the update that had been made. It was decided that the difficulties experienced with the Examod system would be followed up and that the use of this system next term would be reassessed.
2. It was decided that the relevant departments would be reminded of the matter of sending the question-learning objective matrices to be prepared, together with the examination documents, to the Dean's Office, for the written examinations of clerkships that do not use the Examod software.
3. In the verbal reports received, it was understood that the "Mini Clinical Evaluation" section in the intern logbooks is sometimes not filled in properly, and it was stated that it would be appropriate to issue a reminder on this matter to the Term 6 clerkship coordinators.
